PURPOSE



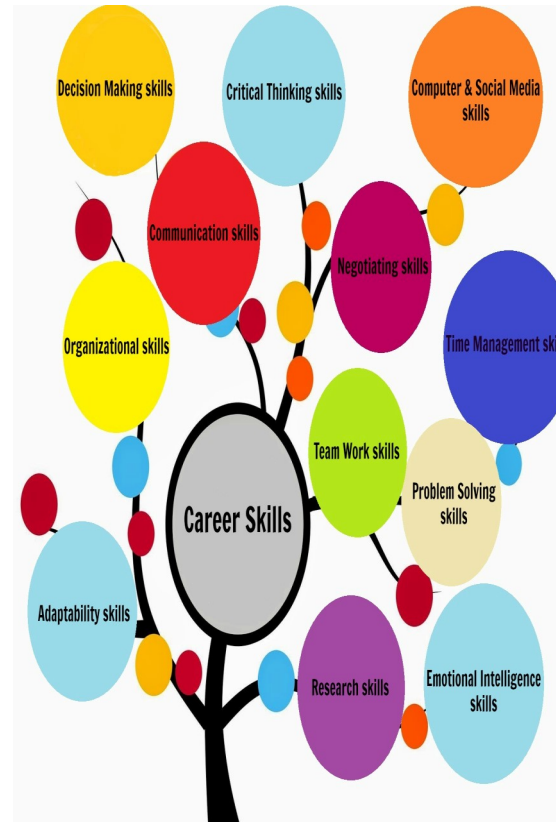
What is the purpose of a BAC?:

Business advisory councils foster cooperation among schools, businesses and the communities they serve. This work ensures that the work of educators aligns with the needs of businesses. This cooperation can make a local education system more aware of the local labor market; promote work based experiences within businesses; and help students prepare for successful learning and employment opportunities.

4. To aid and support local school districts by offering suggestions for developing a working relationship among educators, business and labor organizations.

REQUIREMENTS AND RESPONSIBILITIES

The requirements for business advisory councils were first enacted under Ohio Revised Code (ORC) Section 3313.174. Under ORC 3313.82, all school districts must have a business advisory council unless a district has set up a service agreement with an Educational Service Center (ESC). All school districts served by the Fairfield County ESC agreed that the ESC's business advisory council may act as their business advisory council.

The Business Advisory Council's responsibilities under 3313.82 include advising and providing recommendations on the delineation of employment skills and the development of curriculum to instill these skills; on changes in the economy and in the job market, and the types of employment in which future jobs are most likely to be available; on suggestions for developing a working relationship among businesses, labor organizations and educational personnel.
